In the event of an emergency or if the musician cancels within Seven days prior to the event. The musician must arrange alternative performers at no extra cost to the client. If this is not possible, all monies received will be returned to the client.

If the performance area is outdoors, the client agrees to provide protection from sun, wind and rain for the musician/s.

Client will also ensure the musicians have access to a safe stage area with direct electrical supply and must have enough safe space to setup the equipment and designated area to sit to perform his music.
